

LEGAL NOTES & CONDITIONS OF SALE

- For the **DIRECT DISTRIBUTION** of sporting rifle & shotguns we **MUST** receive a NZ Police MAIL ORDER FORM. This will be sent by E-mail or post to Hayes & Associates Ltd
- A **PERMIT to PROCURE** is needed for **ALL pistol** and **MSSA** sales within New Zealand (Excluding genuine antique percussion & flintlock pistols and other antique firearms)
- For overseas firearm and firearm parts sales we need the full name, address, phone/fax number/E-mail details, firearm licence details, a copy of the IMPORT PERMIT – or a letter from the customer's police department or BAFTA equivalent, delivery address (to a licensed arms dealer is preferred) and credit card details. Hayes & Associates will need to apply for a NZ FOREIGN AFFAIRS DEPT Export License – these take approximately two weeks to obtain. Delivery is by international air freight. NZ Post will not accept firearms!
- Sales of all NEW firearms, electrical goods and accessories are covered by a minimum ONE-YEAR factory warranty – except where specified otherwise.
We do not warrant or service any parallel imported goods
- Warranty will be null and void if firearms have been misused, with - without our approval
- Faulty goods still under warranty will be repaired free of charge and we carry a very comprehensive range of spare parts - with all sales backed up by superior after sales service. **If a problem is experienced please contact H&A LTD before returning the item.**
- **No used goods can be returned for financial payment.** Faulty goods will be repaired or replaced
- **There is no warranty coverage by H&A Ltd on UBERTI, PEDERSOLI, BREDIA, CHIAPPA, BREDIA, FAIR, PIETTA, ARMED or HUGLU firearms that have been parallel imported by other NZ companies or individuals – and any parts needed will be 300% more than our usual price for spare parts**
- We can also supply - WINCHESTER, REMINGTON, ROSSI, TASCO, BUSHNELL & HORNADY products at very good prices. Plus all LYMAN, LEE, REDDING, HORNADY & RCBS reloading equipment - at the best prices
- UBERTI, PEDERSOLI, BREDIA, FAIR, CHIAPPA, PIETTA & HUGLU not normally stocked can be obtained on INDENT at the very best prices.
- For all INDENT orders we require a **NON-REFUNDABLE** (except in exceptional circumstances) ½ **DEPOSIT** with the order
- **We do not accept firearms for sale "on behalf" but we do accept firearms as 'trade-in' items, or on a sale & purchase arrangement**
- We offer a depository service, whereby firearms can be stored with Hayes & Associates Ltd – at a cost of \$5 per week per firearm
- All prices on our monthly stock list include GST, but not freight
- Payment can be made by CHEQUE, CASH, VISA, MASTERCARD, or AMERICAN EXPRESS deductions via credit cards – or direct to our ANZ Account
- Appropriate packaging & freight costs will be added to all orders
